* The GPYC is allowing boat lifts in selected wells, please read the rules and regulations if interested and contact the Harbor Master with any questions.

2019 Boat Hoist Rules and Regulations

1. Timmerman Brand Boat Lifts are the only approved brand for installation/maintenance/removal contactors. Alex has the order binder at the Harbor Office. No other brands may be used. In the event that Timmerman is no longer available, the Harbor Committee will approve a new brand.
2. Only new lifts, cables, hoses, and controls may be used in the harbor, lift provider will supply a 120-volt power cord with GFCI.
3. Members are financially responsible for purchasing, installing, maintenance, and removal of the boat lifts.
4. Boat lifts used for a member's #1 vessel do not have to be removed at the end of the boating season before the harbor closes. Lifts used for member's second vessels must be removed from the harbor by Timmerman at the member's expense at the end of each season because there is no guarantee the member will get the same well the following year.
5. All lift pumps/electrical systems and controls must be kept in a GPYC white fiberglass dock box which must be kept locked by the member when the lift not in use. The locks will be combination type all with the same code for any emergency. Members will have to pay for a new dock box from Harbor Office to be consistent with the harbor.
6. No canopy or upright poles are allowed on the lifts.
7. If a lift in a well assigned to a member on a permanent basis requires cleaning in the spring, a member may make arrangements with the Harbor Master to have the Harbor
8. Masters' crew members perform cleaning with the member responsible for the costs involved. Any mechanical or electrical maintenance or repairs must be done by the lift provider at the member's expense. All slips are assigned on a Temporary basis until all harbor renovations are completed.
9. No winter storage or bubbling of vessels on lifts will be allowed.
10. If dredging in a well is required in order to properly install a lift, the member will be responsible for the dredging costs.
11. No installation or removal of lifts on weekends or Holidays.
12. Lift provider will be required to use only biodegradable fluids/hydraulics/oils. R.D. Galeota to contact Timmerman about proper Bio-degradable fluids.

13. The maximum boat length is 85% of the designated well to be eligible for the lift program, and the boats are limited to center console models or low profile vessels with silent exhaust systems. No express cruisers, yachts, Jet Skis, or sailboats are allowed. T-Dock North slips 2-7 only limited to availability, as designated by the Harbor Committee and Harbormaster. Vessels must have outboards or silent exhaust.
14. Members are responsible for removing lifts within 60 days from the date the member relinquishes/surrenders the assigned well containing the lift. Any member or former member who fails to remove the lift within 60 days of relinquishing/surrendering the well containing the lift will forfeit the lift to the GPYC, which shall become the legal owner of the lift as a result of the forfeiture.
15. All decisions regarding the future use of hoists in the harbor will be at the discretion of the Harbor Committee regardless of the above recommended rules.
